Minutes

Trustees Meeting, 14 February 2007. Edward A. Hazlett Meeting Room, Winthrop Public Library.

Mr. Matarazzo called the meeting to order at 6:34 P.M. The following trustees were present: James Matarazzo, Chairman; Alex Alexanian, Vice-Chairman; Stephen Dalton, Betty Peabody. The library was represented by John Cronin, Director and Janice Flaherty, Administrative Assistant.

Minutes

Mr. Dalton moved to accept the minutes of 10 January 2007. Alex seconded the motion. Unanimous.

Old Business

- A. Motion to approve \$10,000. from the Hyde Fund to strip and paint the Circulation room. After a discussion a vote was taken. Betty and Steve voted in the affirmative and Alex voted against the motion. The vote passed 2 to 1.
- B. MHC grant survey, bid, project description complete. Release of \$40,000 for painting, electrical work, plaster, alarm, carpeting in the museum.
- C. Union grievance—Christopher Reeves. Executive session—Mr.

 Matarazzo motioned to discuss grievance. Ms. Peabody seconded the motion. The Town Manager, Mr. White, agrees with Reeves and the Library has offered 12.5 hours/week on Thursdays and Saturdays.

New Business

- A. Mr. Cronin advises us that between 1 July 06 and 31 December 06 more than \$2000. has been collected from ?. The money will be used for buying library materials. A grant request has been submitted to MBLC in the amount of \$6795. for matching funds.
- B. Request up to \$3500. from State Aid to remove old shelving and purchase/install new shelving for Reference area. Mr. Dalton made the motion to withdraw \$3500. from State Aid for shelving etc. Mr. Alexanian seconded motion which passed unanimously after discussion.
- C. Mr. Cronin's Christmas holiday expenses (\$449.75). Mr. Dalton made a motion to move \$449.75 from the Hyde Fund to repay Mr. Cronin. Mr. Alexanian seconded. Unanimous.
- D. Requests for transfer from State Aid. Mr. Dalton moved to transfer \$449. for a scanner and a digital camera Mr. Alexanian seconded. Unanimous.
- E. Mr. Cronin discussed the "Books for Belize" program. The library and the Friends group will participate in donating books.
- F. Mr. Cronin's "retirement"—John is willing to stay on as Director until 12.31.07 or if needed during the hiring period of a new Director.
